**Petition Form for Waterside** 

Sussex Community Improvement (SCI) Program

Dear Waterside Property Owner:

Your Property Owners Association requested Sussex County include the Waterside community in the SCI Program as prescribed by Sussex County Code, Chapter 96. The request is primarily to **restore community roadway pavement**. The County would oversee all work and subsequently finance the total project cost for Waterside owners to repay through an additional County annual assessment over a fixed period of years.

The SCI Program has steps to confirm community interest and eligibility. The enclosed Petition Form is to confirm a majority of owners conceptually agree with repaying all project costs. Sussex County developed the enclosed Preliminary Cost Estimate to summarize an initial project scope and cost. The estimate indicates each assessable property owner would have their annual County billing increased by approximately \$800.00 for a ten-year period. Please note, balance payments of the \$5,705 total estimated assessment would be permitted to eliminate or reduce interest charges associated with financing the project cost.

Please mail or deliver the petition to Patrick Brown, Project Engineer, at the address below ONLY IF YOU AGREE with the concept of funding community roadway improvements.

Owners must sign the Petition Form in the presence of a notary public, and per County Code each assessable property may only sign one (1) petition regardless of the number of owners or type of ownership. With advance notice, a notary is available to assist you at the County Administrative Offices. Please note, if a property is corporately owned the necessary Corporation Affidavit is provided with the petition to confirm signing rights. Faxed or e-mailed petition documents cannot be accepted.

We ask that you return the executed petition on or before <u>December 22, 2023.</u> If greater than fifty percent (50%) of assessable owners return petitions, an informal public meeting will be scheduled to discuss the project scope and costs in more detail. An Election approved by Council Resolution would then occur to formally vote on whether to proceed with a community improvements project. As per Code, each
